- On request by a consumer, any supplier of an article containing a substance meeting the criteria in Article 57 and identified in Article 59(1) in a Result above 0.1% weight by weight(w/w) shall provide the recipient of the article with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance. The relevant information shall be provided, free of charge, within 45 days of receipt of the request.

2. According to the Article 33 of the Regulation (EC) No 1907/2006(REACH)-Notification of the Substance in Article.

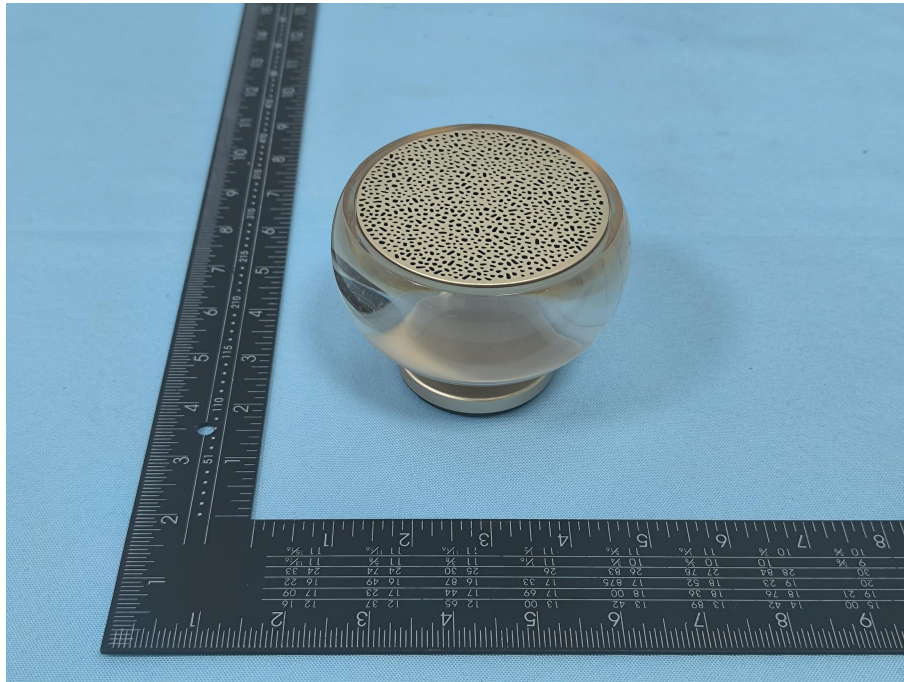

From 5 January 2021, if SVHC substances are present in an article placed on the EU market in a concentration above 0.1 % w/w, the EU supplier of that article needs to submit a SCIP notification to ECHA under the EU Waste Framework Directive (WFD, Directive 2008/98/EC). After 5 January 2021, if substances present in an article as such or in a complex object placed on the EU market in a concentration above 0.1 % w/w are added to the Candidate List, the supplier of that article need to submit a new SCIP notification or update a previous submitted SCIP notification for that article at the time of the next supply or placement on the market to any customer or as a result of an import, after the substance has been included in the Candidate List.
